CABOOLTURE DISTRICT EXEMPTION FROM ATTENDING A DISTRICT TRIAL PROCESS

Process to follow:

STEP 1

- You must be enrolled in a school that is affiliated in the representative school sport program, or be enrolled in and affiliated distance education school or facility, or be a registered for home schooling.
- You must advise our district team official, or our committee administrator that you are unable to attend a district trial event.
- You must meet an approved criterion for exemption (see Absentee Application form for criteria).

STEP 2

- The district committee's authorised delegate assesses if you are eligible to apply to be exempt from attending our district trial.
- You must then download a copy of our Application for Exemption form or get a copy from your school sport co-ordinator.
- You must complete the form, and ensure that you have all the necessary supporting documents that we require (such as a signed medical certificate and sporting achievement resume, etc).
- Remember that the exemption application form and the supporting documents must be received by our district administrator no later than 24 hours prior to the commencement of our district trial.

STEP 3 - actions to take

- You must email the exemption application form and the supporting documents to our district administrator. See our Application for Exemption form for contact details.
- Remember to attach all supporting documents in your email along with the signed Exemption application form.
- It is your responsibility to meet the required timelines. Our committee reserves the right to not accept late applications.

STEP 4 – committee assessment of an exemption application

- Our district committee will review your application and supporting documents.
- We will email you to let you know if your application is accepted and approved or not.
- We will let your school know if your exemption application is approved or not.
- We will let our district trial event officials know about all approved exemption applications so that they can consider them for team selection.

STEP 5 - at the district trial event

- Our district event officials will let other attendees know that there are exempted students who will be considered for selection in our district sport team.
- During our district trial event, officials from our district will compare approved exemptions with attendees. They will take into account playing skills, fitness, and sporting behaviours. They will also compare the documentation of exempted students, such as sporting accomplishments and playing history, potential fitness levels, etc., with trial event attendees for selection into our district sport team.
- We will let all approved exempted students know the outcome of the trial selection. Whether they have been selected or not to join our district sport team.
